Dear Sir or Madam,

you will soon receive a Lina wheelchair as a second use, i.e. the wheelchair has already been used with a child and is now available for use.

Families who apply for a wheelchair have to answer a series of questions and also sign a waiver of liability towards to the association Lina's Rolli's e.V.

As we assemble the Rolli's by hand and do not carry out any complex and costly testing procedures, the use is at your own risk.

Therefore, it is also necessary for you to release us from liability for any injuries. You are responsible for supervising children who use the wheelchair.

The wheelchair is handed over to you and remains in your facility and is not subject to return to us, unless you have requested us to do so.
